AN ORDINANCE TO AMEND THE 2022 CAPITAL FUND BUDGET FOR THE REC PARK TENNIS COURTS

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Capital Fund budget to (i) create a budget line for Rec Park Tennis Courts and (ii) increase the insurance recovery at the Rec Park Tennis Courts in the amount of \$557,659; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on July 20, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Capital Fund budget to (i) create budget line H7110.525277 (Rec Park Tennis Court) for the Rec Park Tennis courts and (ii) increase the insurance recovery at the Rec Park Tennis Courts in the amount of \$557,659 as follows:

- (i) \$557,659 increase revenue budget line H.42680 (Insurance Recovery)
- (ii) \$557,659 increase expense budget line H7110.525277 (Rec Park Tennis Court)

Section 2. That this Ordinance shall take effect immediately.
