## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 BUDGET TO TRANSFER FUNDS FOR THE LEAD RISK ASSESSMENT

WHEREAS, the HUD Manager and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget to transfer funds for the Lead Risk Assessment in an amount not to exceed \$15,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 24, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
