**AN ORDINANCE TO AMEND THE 2022
BUDGET TO TRANSFER FUNDS FOR THE
LEAD RISK ASSESSMENT**

WHEREAS, the HUD Manager and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget to transfer funds for the Lead Risk Assessment in an amount not to exceed \$15,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 24, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 budget to transfer funds for the Lead Risk Assessment in an amount not to exceed \$15,000 as follows:

Transfer From (Decrease):

\$ 5,000 CD8668.533509.CDY45
(Homeownership/Rehab)
\$10,000 CD8668.533509.CDY46
(Homeownership/Rehab)

\$15,000

Transfer To (Increase):

\$15,000 CD8668.533526.CDY47 (Lead
Risk Assessment)

Section 2. That this Ordinance shall take effect immediately.
