## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 CAPITAL BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR SEWER AND WATER LINE IMPROVEMENTS

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Capital budget to allocate American Rescue Plant Act (ARPA) funds in the amount of \$400,000 for sewer and water line improvements; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 24, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Capital budget to allocate American Rescue Plant Act (ARPA) funds in the amount of \$400,000 for sewer and water line improvements as follows:
  - (i) \$400,000 increase expense budget line A9950.59000.F0015 (Interfund Transfer-ARPA)
  - (ii) \$400,000 increase revenue budget line A44089.F0015 (Federal Aid-ARPA)
  - (iii) \$400,000 increase revenue budget line H.45031.F0015 (Interfund Transfer-ARPA)
  - (iv) \$350,000 increase expense budget line H8120.525055.F0015 (Replace Sewer Lines)
  - (v) \$ 50,000 increase expense budget line H8320.525058.F0015 (Water lines)

Section 2. That this Ordinance shall take effect immediately.
