WHEREAS, the Director of Planning, Housing, and Community Development and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Planning and Zoning budget to defund a part-time Clerk position, as provided in Permenant Ordinance 22-100, dated June 22, 2022, and to fund a full-time Planner position at an annual salary of \$42,042; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 7, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. RESOLVE that all displays are subject to approval by the Fire Marshall; and be it further RESOLVE that Dynamic Effects & Fireworks Company pay all applicable fees, and comply with all safety precautions, road closings, and other requirements and obligations a required by the Code of the City of Binghamton § 229-2, *Fireworks authorized*, § 235-18, *Fireworks displays*, and New York State Penal Law § 405; and be it further

RESOLVE that Dynamic Effects & Fireworks Company will comply with all New York State guidelines regarding the COVID-19 pandemic, if any, regarding attendance and such fireworks displays.
