AN ORDINANCE TO AMEND THE 2022
BUDGET FOR DEMOLITION AND AIR
MONITORING OF A FIRE-DAMAGED
BUILDING AT 44 LAKE AVENUE

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget for demolition and air monitoring of a fire-damaged building at 44 Lake Avenue, in the amount of \$26,740.25; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 21, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the 2022 budget for demolition and air monitoring of a fire-damaged building at 44 Lake Avenue, in the amount of \$26,740.25 as follows:

- (i) \$26,740.75 increase revenue budget line M.42680 (Insurance Recoveries)
- (ii) \$26,740.75 increase expense budget line M1910.54470 (Demolition)

Section 2. That this Ordinance shall take effect immediately.
