

## **ORDINANCE**

## AN ORDINANCE TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS TO VINES

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to (i) create a new budget line for Safety Net VINES Building and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$300,000 to VINES for the development of a new VINES office and community space to support the Grow Binghamton youth program and efforts to combat food insecurity; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 5, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) create a new budget line for Safety Net VINES Building and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$300,000 to VINES for the development of a new VINES office and community space to support the Grow Binghamton youth program and efforts to combat food insecurity as follows:
  - \$300,000 increase revenue budget line A.44089.F0015 (ARPA Revenue)
  - \$300,000 increase expense budget line A6140.52000.F0015 (SAFETY NET-(ii) VINES BUILDING)

Section 2. That this Ordinance shall take effect immediately.
