A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE BINGHAMTON CITY SCHOOL DISTRICT FOR USE OF AMERICAN RESCUE PLAN ACT FUNDS

WHEREAS, the Mayor of the City of Binghamton wishes to enter into an agreement with the Binghamton City School District for use of American Rescue Plan Act (ARPA) funds, in an amount not to exceed \$250,000, for trauma-informed care and community violence intervention.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Council of the City of Binghamton hereby approves the above-subject Project; and be it further

RESOLVED that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Binghamton City School District for use of ARPA funds, at a cost not to exceed \$250,000; and that funds shall be deducted from budget line A7310.54163.F0015 (ARPA Youth Programming) for this purpose.
