A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE AGREEMENT WITH FAMILY ENRICHMENT NETWORK

WHEREAS, pursuant to Permanent Resolution 21-74, dated September 1, 2021, the City of Binghamton entered into an agreement with various agencies for use of ESG CDBG COVID funds for homeless prevention services; and

WHEREAS, the agreement with Family Enrichment Network was awarded CDBG funds in an amount not to exceed \$250,000 for rental assistance; and

WHEREAS, the HUD Manager recommends (i) increasing the amount of the existing agreement to \$369,320; and (ii) extending the contract to September 30, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to amend the agreement, approved as to form and content by the Office of Corporation Counsel, with Family Enrichment Network for rental assistance; and that this amendment will increase the amount of the existing agreement to \$369,320; and extend the contract to September 30, 2023; and the additional funding will come from CD8760.535003.CVY46 for \$119,320 for this purpose.
