ORDINANCE

AN ORDINANCE TO AMEND THE 2022 SEWER BUDGET TO DEFUND A PUMP STATION HELPER AND ADD A LABORER

WHEREAS, the Water & Sewer Superintendent and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Sewer budget to defund a "Pump Station Helper" position, and add a "Laborer" position at an annual salary of \$41,517; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 16, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

That the Comptroller and City Treasurer of the City of Binghamton are Section 1. hereby authorized and directed to amend the 2022 Sewer budget to (i) defund a "Pump Station Helper" position, (ii) add a "Laborer" position at an annual salary of \$41,517; and (iii) fund the "Laborer" position from November 21, 2022 to December 31, 2022 as follows:
