**AN ORDINANCE TO AMEND THE 2022 DPW
BUDGET FOR OVERTIME AND GENERAL
OPERATING SUPPLIES**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 DPW budget for overtime and general operating supplies in the amount of \$10,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 16, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 DPW budget for overtime and general operating supplies in the amount of \$10,000 as follows:
