AN ORDINANCE TO AMEND THE 2022 FIRE BUDGET TO ACCEPT THE NYS HEALTH CARE WORKERS BONUS FOR PERSONAL SERVICES

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Fire budget to accept the New York State Health Care Workers Bonus in the amount of \$167,934; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 16, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Fire budget to accept the New York State Health Care Workers Bonus in the amount of \$167,934 as follows:
 - (i) \$167,934 increase revenue budget line A.43389 (State Aid-Public Safety)
 - (ii) \$156,000 increase expense budget line A3410.51000 (Personal Services)
 - (iii) \$ 11,934 increase expense budget line A9030.58000B (Social Security)

Section 2. That this Ordinance shall take effect immediately.
