AN ORDINANCE TO AMEND THE 2022 FINANCE BUDGET TO INCREASE THE ANNUAL SALARY OF THE STAFF ACCOUNTANT TO \$60,000

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Finance budget to increase the annual salary of the Staff Accountant position from \$59,000 to \$60,000; and

WHEREAS, there are sufficient funds in the existing budget lines because the position has been vacant; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 16, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Finance budget to increase budget line A1310.51000 (Personal Services – Staff Accountant) from \$59,000 to \$60,000.

Section 2. That this Ordinance shall take effect immediately.
