WATER FILTRATION PLANT FILTER MEDIA

WHEREAS, the Council of the City of Binghamton adopted Permanent Resolution 21-79, dated October 6, 2021, with GHD Consulting Services Inc. for the design and bidding of repairs and replacement of the Water Filtration Plant Filter Media; and

WHEREAS, the Superintendent of Water & Sewer recommends the City enter into a Supplemental Agreement No. 1 with GHD Consulting Services Inc. for construction administration services for the Water Filtration Plant Filter Media project at a cost not to exceed \$25,000.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into Supplemental Agreement No. 1, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services Inc. for construction administration services for the Water Filtration Plant Filter Media project, at a cost not to exceed \$25,000; and that funds shall be deducted from budget line H8320.525105.F0015 (Water Plant Improvements) for this purpose.
