AN ORDINANCE TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR NY HELMETS TO HARDHATS INC. FOR WORKFORCE DEVELOPMENT

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to (i) create a new budget line for American Rescue Plan Act ("ARPA") workforce development and (ii) allocate ARPA funds in the amount of \$50,000 for veteran workforce development; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 7, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) create a new budget line for ARPA workforce development and (ii) allocate ARPA funds in the amount of \$50,000 for veteran workforce development as follows:

- (i) \$50,000 increase revenue budget line A.44089.F0015 (Fed.Aid-ARPA)
- (ii) \$50,000 increase expense budget line A9950.59000.F0015 (Interfund Transfer-ARPA)
- (iii) \$50,000 increase revenue budget line H.45031.F0015 (Interfund Transfer-ARPA)
- (iv) \$50,000 increase expense budget line H6989.54402.F0015 (Workforce Development)

Section 2. That this Ordinance shall take effect immediately.
