AN ORDINANCE TO AMEND THE 2022 JOINT SEWER CAPITAL FUND FOR SETTLEMENTS AND DEBTS

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Joint Sewer Capital Fund in the amount of \$16,549,600 to adjust for settlements and pay down debts; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 7, 2022.
