**AN ORDINANCE TO AMEND THE 2022 JOINT
SEWER CAPITAL FUND FOR SETTLEMENTS
AND DEBTS**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Joint Sewer Capital Fund in the amount of \$16,549,600 to adjust for settlements and pay down debts; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 7, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Joint Sewer Capital Fund in the amount of \$16,549,600 to adjust for settlements and pay down debts as follows:

Transfer From (Decrease):

\$16,549,600 HX.45710 (Serial Bonds)

Transfer To (Increase):

\$16,549,600 HX.42960 (Other Compensated Losses)

Section 2. That this Ordinance shall take effect immediately.
