**AN ORDINANCE TO AMEND THE 2022
CAPITAL FUND BUDGET FOR POLICE
VEHICLES**

WHEREAS, the Chief of Police and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Capital Fund budget for Police vehicles in the amount of \$68,453.84; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 7, 2022.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Capital Fund budget for Police vehicles in the amount of \$68,453.84 as follows:

- (i) \$68,453.84 decrease expense budget line A3120.51000 (Per.Ser.Police Grade 1)
- (ii) \$68,453.84 increase revenue budget line H.45031 (Interfund Transfer)
- (iii) \$68,453.84 increase expense budget line A9950.59000 (Interfund Transfer)
- (iv) \$68,453.84 increase expense budget line H3120.550026 (Police Vehicles)

Section 2. That this Ordinance shall take effect immediately.
