ORDINANCE

AN ORDINANCE TO AMEND THE 2022 GENERAL FUND BUDGET FOR TIRES, VEHICLE PARTS AND ELEVATOR SERVICE

WHEREAS, the Commissioner of the Department of Public Works and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 General Fund budget for tires, vehicle parts, and elevator service in the amount of \$42,658.36; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 7, 2022.
