AN ORDINANCE AMENDING THE CODE OF THE CITY OF BINGHAMTON, CHAPTER 265-2, HOUSING AND PROPERTY MAINTENANCE, DEFINITIONS, TO ADD "DETERIORATED"

WHEREAS, the HUD Manager recommends an amendment to the Code of the City of Binghamton, Chapter 265-2, *Housing and Property Maintenance, Definitions*, to add "deteriorated".

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 265-2, *Housing and Property Maintenance, Definitions*, is hereby amended to add "deteriorated" as follows:

DETERIORATED OR DETERIORATING LOCATION: Code Enforcement shall make a determination on each site visit that a property or building is deteriorated and define and document the reason for this determination according to one or more conditions: cracks in the foundation, multiple broken windows, defective construction, lack of proper sanitary facilities or adequate fire or safety protection, illegal uses and conversions, inadequate maintenance, abandoned building(s), and/or obsolete systems of utilities which hamper or impede proper development.

Section 2. That this Ordinance shall take effect immediately.
