AMERICAN RESCUE PLAN ACT FUNDS



RESOLVED that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with NY Helmet to Hardhats Inc. for use of ARPA funds, at a cost not to exceed \$50,000; and that funds shall be deducted from budget line H6989.54402.F0015 (Workforce Development) for this purpose.
