AN ORDINANCE TO AMEND THE 2022 FIRE BUDGET FOR VEHICLE PARTS, EQUIPMENT **MAINTENANCE** AND BUILDING **MAINTENANCE**

WHEREAS, the Fire Chief and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Fire budget for vehicle parts, equipment maintenance and building maintenance, in the amount of \$14,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 21, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Fire budget for vehicle parts, equipment maintenance and building maintenance, in the amount of \$14,000 as follows:
