**AN ORDINANCE TO ALLOCATE AMERICAN
RESCUE PLAN ACT FUNDS FOR PREMIUM
PAY AS APPROVED IN THE BLUE COLLAR
AND SUPERVISORS CONTRACT**

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to allocate ARPA funds in the amount of \$799,095.10 for premium pay including wages and FICA as agreed upon in the approved Blue Collar and Supervisors contract; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 21, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to allocate ARPA funds in the amount of \$799,095.10 for premium pay including wages and FICA as agreed upon in the approved Blue Collar and Supervisors contract.

Section 2. That this Ordinance shall take effect immediately.
