ORDINANCE

AN ORDINANCE TO AMEND THE 2022
GENERAL FUND AND CAPITAL BUDGET FOR
POLICE VEHICLES AND EQUIPMENT

WHEREAS, the Chief of Police and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 General Fund and Capital budget for police vehicles and equipment in the amount of \$450,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 21, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 General Fund and Capital budget for police vehicles and equipment in the amount of \$450,000 as follows:

- (i) \$450,000 decrease expense budget line A3120.51000 (Per.Ser.)
- (ii) \$450,000 increase expense budget line A9950.59000 (Interfund Transfer)
- (iii) \$100,000 increase expense budget line H3120.550007 (Equip./Repair)
- (iv) \$350,000 increase expense budget line H3120.550026 (Police Vehicles)
- (v) \$450,000 increase revenue budget line H.45031 (Interfund Transfer)

Section 2. That this Ordinance shall take effect immediately.
