AN ORDINANCE TO AMEND VARIOUS SECTIONS OF CHAPTER 124, PERSONNEL POLICIES, OF THE CODE OF THE CITY OF BINGHAMTON

WHEREAS, the Council of the City of Binghamton wishes to amend various sections of the Code of the City of Binghamton, Chapter 124, *Personnel Policies*.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, §124-39, *Definition*; Chapter 124, *Personnel Policies*, §124-39.A, *Standard Work Day*; Chapter 124, *Personnel Policies*, §124-40, *Salary Increases*; and Chapter 124, *Personnel Policies*, §124-44, *Health Insurance & Disability Benefits*, be amended as shown in the attachment.

Section 2. That this Ordinance shall take effect January 1, 2023.

#### Chapter 124, PERSONNEL POLICIES

The provisions of this article shall be applicable to the officers and employees to the extent allowable under law.

Salary increases for officers and employees listed in this Section 2, except the Police Chief, Fire Chief, and Assistant Police Chiefs, are pursuant to Permanent Ordinance No. 05-40, to wit: (i) That the Mayor is authorized to provide annual salary increases to positions contained in this in Section 2 on parity with those received by represented CSEA employees; (ii) In no year shall the annual salary increase provided for in this Section 2 be paid out until a collective bargaining agreement has been fully executed by and between the City of Binghamton and the CSEA for that year; and (iii) No retroactive payment shall be issued to the positions listed in this Section 2 until after or contemporaneous with the date upon which retroactive payments are issued to the members of the CSEA.

Salary increases for the Police Chief, Fire Chief, and Assistant Police Chiefs are pursuant to § 124-40, Salary increases, below.

#### § 124-40. Salary increases. [Amended 12-21-1992 by Ord. No. 92-122; Amended 4-7-2008 by Ord. No. 16-2008; Amended 8-18-2010 by Ord. No. 10-39; Amended 8-4-2021 by Ord. No. 21-75]

- A. Officers and employees, other than elected officials, may be awarded annual salary increases from an annual salary increase pool, The annual salary increase pool shall be the current annual salary of eligible officers and employees multiplied by the average rate increase received by the City's collective bargaining units for that year; provided, however, that any settlement imposed by an arbitration panel shall not be included in the average. If less than three bargaining units are settled in a particular year, then the annual salary increase pool shall be the current annual salary of eligible officers and employees multiplied by the average New York consumer price index as determined by the U.S. Department of Labor for the preceding twelve (12) month average as of October 1. When at least three bargaining units are settled thereafter, the annual salary increase pool will be adjusted accordingly. Only current or retired officers and employees will be eligible for retroactive pay adjustments. The City Council of the City of Binghamton may provide, by ordinance, for a rate increase in excess of that provided for above, for any position listed in § 124-39. This section does not include officers and employees covered under Permanent Ordinance No. 05-40. An increase in salary will not increase longevity pay, if any. This section is effective immediately.
- B. Except as provided in Subsection C below, using the average annual salary increase received by all the City's collective bargaining units, the administration, the Mayor, and his or her administrative staff may provide any amount of increase to eligible officers and employees based either on cost of living and/or merit or a combination of the two so long as the maximum amount of annual salary increases does not exceed the pool so established herein.

C. Increases for City Clerk and Assistant City Clerk. [Added 6-20-2005 by Ord. No. 05-38]

(1) The Common Council shall determine whether the City Clerk and/or the Assistant City Clerk should receive an annual salary increase and the amount of said increases if any are

provided for.

(2) It shall be the responsibility of the Employees Committee of the Common Council to forward to the Council as a whole its recommendation as to whether there should bean increase in the salary of either the City Clerk or the Assistant City Clerk, along with the percentage of any increase for the next fiscal year, by the first work session of August July in the preceding fiscal year.

The recommendation of the Employees Committee may or may not be adopted by the Common Council by a majority vote of its members for a resolution stating the percentage of any increases for either position at a regularly scheduled meeting no later than the first

regularly scheduled meeting in September August.

(4) If such a resolution is adopted, a copy of the resolution shall be forwarded to the Mayor of the City of Binghamton for his or her consideration in the preparation of the proposed budget for the next fiscal year.

- D. In accordance with any annual salary increase provided to any officer and employee, the department supervisor shall advise said employee or officer of that portion which is deemed cost of living versus that portion which is deemed a merit increase based on the prior year's job performance. In addition, supervising personnel should provide annual evaluations of job performance to each and every officer and employee eligible pursuant to this section.
- E. Longevity. Beginning with the first pay period in 2009, the City will include longevity pay in the "regular rate of pay." Longevity will be calculated as of the anniversary date of employment. The City will use the following longevity payment amounts:

15-20 years of service \$500 21-25 years of service \$750 26-29 years of service \$1,000 30 + years of service \$1,250

- F. Compensation for Assistant Police Chiefs (up to two positions). Effective July 10, 2010, Assistant Police Chiefs are officers and employees not covered by a collective bargaining agreement and will receive salary and benefits as follows:
  - (1) Base salary of \$74,635 and "other compensation" consistent with General Municipal Law § 207-m, as may be amended from time to time.
  - (2) Increases to base salary and "other compensation" consistent with General Municipal Law § 207-m, as may be amended from time to time; to wit as of July 10, 2010, the Assistant Police Chiefs will receive at least\_the same dollar amount percentage increase in base salary and increases in "other compensation" as a permanent full-time police officer who is a member of a negotiating unit and who is the highest ranking subordinate to the Assistant Police Chiefs
    - "other compensation" as a permanent full-time police officer who is a member of a negotiating unit and who is the highest ranking subordinate to the Assistant Police Chiefs, i.e., a Captain, in such unit. The Assistant Chiefs will be eligible for overtime as may be directed by the Commissioner of Public Safety (the Mayor). Overtime will be paid at time and one half in the applicable pay period. Assistant Chiefs are not entitled to compensatory time or overtime. off in lieu of overtime payments.
- G. Compensation for the Police Chief. Effective January 1, 2006, the Police Chief will receive salaryand benefits as follows:
  - (1) Base salary of \$85,715 and "other compensation" as provided in General Municipal Law§ 207-m, as may be amended from time to time.
  - (2) Increases to base salary and "other compensation" as provided in General Municipal Law§ 207-m, as may be amended from time to time; except as of July 10, 2010, the Police Chief will receive at least\_the same dollar amount percentage increase in base salary increase as an Assistant Police Chief would have received if an Assistant Police Chief received the same percentage increase\_as a permanent full-time police officer who is a member of a negotiating unit and who is the highest ranking subordinate to the Assistant Chief, i.e., a Captain, in such unit. The Police Chief is not entitled to compensatory time or overtime.
- H. Compensation for the Fire Chief. Effective January 1, 2006, the Fire Chief will receive the salary and benefits as follows:
  - (1) Base salary of \$85,715 and "other compensation" as provided in General Municipal Law§ 207-m, as may be amended from time to time.
  - (2) Same base salary increases as the Police Chief as provided in paragraph G above. Increases to base salary and The Fire Chiefs "other compensation" consistent with General Municipal Law § 207-m, as may be amended from time to time, except as of January 2, 2023, the Fire Chief will receive at least the same dollar amount increase in base salary and "other compensation" as a permanent full-time firefighter who is member of the negotiating unit and who is the highest ranking subordinate to the Chief, i.e. Deputy Chief in such unit. based on the same benefits and obligations as a permanent full time firefighter who is a member of a negotiating unit and who is the highest ranking subordinate to the Fire Chief, i.e., an Assistant Chief. Notwithstanding the foregoing, if the negotiating unit in the Police Bureau does not have a contract for more than one calendar year, the Fire Chief will receive a two (2%) percent increase in base salary per year pending settlement of the collecting bargaining agreement with the negotiating unit in the Police Bureau, at which time there will be a reconciliation and the Fire Chief will be paid the additional amount due and owing or will refund any overpayment to the City. The Fire Chief is not entitled to compensatory time or overtime.
- I. Intermunicipal agreements to share costs and services. Notwithstanding any provision herein, the City may contract to share costs and services with other municipalities or other public entities as may be permitted under the General Municipal Law. Such intermunicipal agreements may include certain positions, including Police Chief, Assistant Police Chiefs, and Fire Chief. Any additional compensation paid to any officer or employee under an intermunicipal agreement will not be included in any of the interrelated calculations in paragraphs F, G, and Habove.

WHEREAS, the Council of the City of Binghamton wishes to amend various sections of the Code of the City of Binghamton to reflect increases in stipends for various Boards and Commissions

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

That the Code of the City of Binghamton, Chapter 225, Electrical

Standards, §225-15, Compensation of Members, is amended as follows:

Once established, these capital budget lines <u>and/or capital reserve funds</u> may not be used for any other purpose, without consent of a majority of the members of both <u>each</u> legislative bodyies.

- G. The Board may be permitted to make budget transfers during the year or within <u>30\_45</u> days thereafter so long as such transfers do not increase the Joint Sewage Project budgeted expenses for the year under the following conditions:
  - i. The Board will give the City Clerk and Village Clerk/Treasurer written notice via email of any proposed budget transfer approved by the Board. The written notice will state if the proposed budget transfer is (ia) for a non-capital item up to \$2,500, (iib) for a non-capital item of more than \$2,500 or cumulative transfers of \$20,000 or more in the calendar year; or (iiic) for a capital item (including transfer[s] to or from the "Capital Reserve" for the Binghamton-Johnson City Joint Sewage Project) noting, when applicable to the established purpose of the source funding, whether such transfer pertains to a declared emergency [such as resulting from an unexpected or imminent equipment or system failure]. The notice will include a copy of the Board's minutes or resolution approving the proposed budget transfer and a RL (request for legislation). The Board will copy said email to the (i) Mayor, President of City Council, Corporation Counsel, and Comptroller of the City and (ii) Mayor, Trustees, Attorney, and Clerk/Treasurer of the Village.
  - ii. Non-capital items. The Board may transfer up to \$2,500 from one budget line to another budget line without legislative approval, except all transfers to increase salary or benefits for any personnel shall require legislative approval. The Board may transfer more than \$2,500 from the contingency budget line to another or various other budget lines, except all transfers to increase salary or benefits for any personnel shall require legislative approval. Any transfer of more than \$2,500 from any budget line or cumulative transfers of \$20,000 or more in the calendar year shall be deemed denied unless a majority of the members of both legislative bodies vote to approve such budget transfer within thirty-five (35) days from the date of receipt of the written notice and RL

(request for legislation) from the Board as required in Section 23.G(i) above.

- iii. Capital items (including transfer[s] to or from the "Capital Reserve" for the Binghamton-Johnson City Joint Sewage Project). Any request for a budget transfer shall be deemed denied unless a majority of the members of both legislative bodies vote to approve such budget transfer within thirty-five (35) days from the date of receipt of the written notice and RL (request for legislation) from the Board as required in Section 23.G(i) above. This provision shall apply to all capital budget lines, whether established before or after this Agreement, as well as to transfer[s] to or from the "Capital Reserve" for the Binghamton-Johnson City Joint Sewage Project.
- iv. No new budget lines will be established without approval of a majority of the members of both legislative bodies.
- v. Any legislative vote required above may be made at a separate or a joint meeting of the legislative bodies.



115-135 Conklin Ave is currently in the I-2 Light & Medium Industrial District and the City is proposing the rezoning of the site to annex it to the adjacent C-4 Neighborhood Commercial District. 115-125 Conklin Ave is currently an Eating & Drinking Establishment and 135 Conklin Ave is a vacant, underutilized formerly industrial building. The principal objective of the rezoning is to make 135 Conklin Ave developable as a mixed-use site, including housing. The rezoning is necessary for this type of development because dwelling units are not permitted in the I-2 District.

On December 12<sup>th</sup>, 2022, the Planning Commission made a motion recommending approval of the proposed rezoning, as the proposal did not conflict with the comprehensive plan, was reasonable given the predominance of non-industrial buildings along Conklin Ave, and would be beneficial to the City given the need for housing. The motion passed unanimously. They then made a motion recommending the issuance of a Negative Declaration under SEQRA, which also passed unanimously.

AN ORDINANCE AUTHORIZING VARIOUS CAPITAL IMPROVEMENTS IN AND FOR THE CITY, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$16,369,000, APPROPRIATING SAID AMOUNT FOR SUCH **PURPOSE** AND **AUTHORIZING** ISSUANCE OF BONDS OF THE CITY IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$16,369,000 TO **FINANCE** APPROPRIATION

WHEREAS, the Council of the City of Binghamton recognizes the need to provide for various capital improvements in and for the City, as more specifically described herein;

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain (by the favorable vote of not less than two-thirds of all the members of said Council) as follows:

Section 1. The City of Binghamton, in the County of Broome, New York (herein called the "City"), is hereby authorized to construct, acquire or undertake the various projects as described in Column A of said Schedule I, attached hereto and made a part hereof, at the estimated maximum costs indicated in Column B of said Schedule I. The estimated total cost of such projects, including preliminary costs and costs incidental thereto and the financing thereof, is \$16,369,000 and said amount is hereby appropriated therefor, such appropriation having been authorized by the Council pursuant to Ordinance No. \_\_\_\_\_\_. The plan of financing includes the issuance of bonds of the City in the principal amount of not to exceed \$16,369,000 to finance said appropriation, and the levy and collection of taxes on all the taxable real property in the City to pay the principal of said bonds and the interest thereon as the same shall become due and payable. Debt service on the obligations herein authorized is expected to be paid from the respective funds of the City set forth in Column D of said Schedule I.

Section 2. Bonds of the City in the aggregate principal amount of not to exceed \$16,369,000 are hereby authorized to be issued in the principal amounts indicated in Column C of said Schedule I for each of the respective objects or purposes indicated in Column A of said Schedule I, pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the

Consolidated Laws of the State of New York (herein called the "Law"), to finance the appropriation referred to herein.

Section 3. The respective periods of probable usefulness of the specific objects or purposes and classes of objects or purposes for which said bonds are authorized to be issued, within the limitations of §11.00 a. of the Law as referenced in Column G of said Schedule I, are set forth in Column F of said Schedule I.

Section 4. The proceeds of the bonds herein authorized, and any bond anticipation notes issued in anticipation of said bonds, may be applied to reimburse the City for expenditures made after the effective date of this Ordinance for the purposes for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this Ordinance, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the City, payable as to both principal and interest by general tax upon all the taxable real property within the City. The faith and credit of the City are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the City by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this Ordinance and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes and Section 50.00 and Sections 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the Council relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, and as to executing agreements for credit enhancements, are hereby delegated to the City Comptroller, the chief fiscal officer of the City.

- Section 7. The validity of the bonds authorized by this Ordinance, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:
- (a) such obligations are authorized for an object or purpose for which the City is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such ordinance, or a summary thereof, are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

Section 8. This bond Ordinance shall take effect immediately, and the City Clerk is hereby authorized and directed to publish the foregoing Ordinance, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in the "The Press & Sun-Bulletin," a newspaper published in Binghamton, New York, having a general circulation in the City and hereby designated the official newspaper of said City for such publication.

Continual erosion and degradation of the riverbank contributes to a higher risk of failure for the existing sewer interceptor. This project will relocate the interceptor sewer and pump station off the riverbank after permits are obtained from the NY DEC and the Army Corps of Engineers.
Findings: The City of Binghamton City Council has determined that the portion of the proposed action described above as relocating the 6th Ward Sanitary Sewer Interceptor is a Type II action based on §617.5 Type II C (13) extension of utility distribution facilities, including gas, electric, telephone, cable, water and sewer connections to render service in approved subdivisions or in connection with any action on this list and (21) minor temporary uses of land having negligible or no permanent impact on the environment; and no further environmental review is necessary.

#### **ORDINANCE**

AN ORDINANCE AUTHORIZING THE 6TH WARD INTERCEPTOR SANITARY SEWER PROJECT, STATING THE **ESTIMATED** MAXIMUM COST THEREOF IS \$13,000,000, APPROPRIATING SAID AMOUNT FOR SUCH **AUTHORIZING** PURPOSE AND ISSUANCE OF BONDS OF THE CITY IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$13,000,000 **FINANCE** TO APPROPRIATION

WHEREAS, the City of Binghamton, in Broome County, New York has heretofore on February 8, 2017 (the "2017 Authorization"), authorized the issuance of bonds in the principal amount of not to exceed \$1,500,000 for the 6<sup>th</sup> Ward Interceptor Sanitary Sewer Project (the "Project"); and

WHEREAS, the City expect to continue to use funds borrowed pursuant to the 2017 Authorization to finance costs of the Project; and

WHEREAS, based upon recent estimates received by the City, said Project is expected to cost approximately \$13,000,000, said amount being in addition to the amount previously authorized for the Project pursuant to the 2017 Authorization; and

WHEREAS, the Common Council recognizes the need to provide for the Project, as more specifically described herein and will hereby authorize the issuance of bonds of a like principal amount to finance said cost of the Project.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain (by the favorable vote of not less than two-thirds of all the members of said Council) as follows:

Section 1. The City of Binghamton, in the County of Broome, New York (herein called the "City"), is hereby authorized to undertake the 6th Ward Interceptor Sanitary Sewer Project (the "Project"). The estimated maximum cost of the Project, including preliminary costs and costs incidental thereto and the financing thereof, is \$13,000,000 and said amount is hereby appropriated therefor, such appropriation having been authorized by the Council pursuant to Ordinance No.

\_\_\_\_\_\_. The plan of financing includes the issuance of bonds of the City in the principal amount of not to exceed \$13,000,000 to finance said appropriation, and the levy and collection of taxes on

all the taxable real property in the City to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

- Section 2. Bonds of the City in the principal amount of not to exceed \$13,000,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called the "Law"), to finance the appropriation referred to herein.
- Section 3. The period of probable usefulness applicable to the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 4 of the Law, is forty (40) years.
- Section 4. The proceeds of the bonds herein authorized, and any bond anticipation notes issued in anticipation of said bonds, may be applied to reimburse the City for expenditures made after the effective date of this Ordinance for the purposes for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.
- Section 5. Each of the bonds authorized by this Ordinance, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the City, payable as to both principal and interest by general tax upon all the taxable real property within the City. The faith and credit of the City are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the City by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.
- Section 6. Subject to the provisions of this ordinance and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds with substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes and Section 50.00 and Sections 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the Council relative to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, and as to executing agreements for credit enhancements, are hereby delegated to the City Comptroller, the chief fiscal officer of the City.
- Section 7. The validity of the bonds authorized by this Ordinance, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:
  - (a) such obligations are authorized for an object or purpose for which the City is not authorized to expend money, or

## AN ORDINANCE TO UPDATE THE CONTRACT OF SALE FOR 72 COURT STREET
