WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 General Fund budget for Bond Principal in the amount of \$205,399.43; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
