**AN ORDINANCE TO AMEND THE 2022
GENERAL FUND BUDGET FOR TEMPORARY
SERVICES**

WHEREAS, the Corporation Counsel and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 General Fund budget for temporary services in the amount of \$1,200; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 General Fund budget for temporary services in the amount of \$1,200 as follows:

Transfer From (Decrease):


\$1,200 A1420.51000 (Per.Ser.1st Asst.)

Transfer To (Increase):

\$1,200 A1420.51800 (Temp.Ser.)
