WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 General Fund budget for various services in the Personnel budget in the amount of \$6,043; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 General Fund budget for various services in the Personnel budget in the amount of \$6,043 as follows:

Transfer To (Increase):

\$ 100 A1430.51800 (Temp.Ser.)
3,000 A1430.54650 (Legal Ads)
2,943 A1430.54701 (Travel/Training)
\$6,043

Section 2. That this Ordinance shall take effect immediately.
