**AN ORDINANCE TO AMEND THE 2022  
GENERAL FUND BUDGET (DPW) FOR SALT  
AND SAND**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 General Fund budget (DPW) for salt and sand in the amount of \$99,667; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 25, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend 2022 General Fund budget (DPW) for salt and sand in the amount of \$99,667 as follows:

- (i) \$99,667 increase revenue budget line A.49999 (Fund Balance)
- (ii) \$99,667 increase expense budget line A5142.54141 (Salt/Sand)

Section 2. That this Ordinance shall take effect immediately.
