AN ORDINANCE TO AMEND THE 2023  
PLANNING BUDGET FOR PERSONAL  
SERVICES

WHEREAS, the Director of Planning, Zoning & Historic Preservation and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 budget to defund the Historic Preservation & Neighborhood Planner II in the amount of \$51,795 and fund a Historic Preservation & Neighborhood Planner I position in the amount of \$47,500; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 25, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend 2023 budget for personal services in the amount of \$51,795 to fund and add a Historic Preservation & Neighborhood Planner I position as follows:

Transfer From (Decrease):

\$51,795 A8684.51000 (His.Pres.Plan.II)(8)

Transfer To (Increase):

\$47,500 A8684.51000 (His.Pres.Plan.I)(8)  
4,295 A1990.55000 (Contingency)

\$51,795

Section 2. That this Ordinance shall take effect January 28, 2023.
