AN ORDINANCE TO AMEND THE 2023 PLANNING BUDGET FOR PERSONAL SERVICES

WHEREAS, the Director of Planning, Zoning & Historic Preservation and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 budget to defund the Historic Preservation & Neighborhood Planner II in the amount of \$51,795 and fund a Historic Preservation & Neighborhood Planner I position in the amount of \$47,500; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 25, 2023.
