**AN ORDINANCE TO AMEND THE 2023 PARKS
& RECREATION BUDGET TO DEFUND 9
LABORER POSITIONS AND FUND 9 PARK
TECHNICIAN POSITIONS WITH NO CHANGE
IN SALARY**

WHEREAS, the Commissioner of Parks & Recreation and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Parks & Recreation budget to (i) defund 9 "Laborer" positions at an annual salary of \$43,285 and (ii) add 9 "Park Technical" positions at an annual salary of \$43,285; and

WHEREAS, the title change requires no change in salary; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Parks & Recreation budget to (i) defund 9 "Laborer" positions at an annual salary of \$43,285 and (ii) add 9 "Park Technical" positions at an annual salary of \$43,285; and the title change requires no change in salary.

Section 2. That this Ordinance shall take effect March 18, 2023.
