ORDINANCE

AN ORDINANCE TO AMEND THE 2023 PARKS & RECREATION BUDGET TO DEFUND A MEO POSITION AND FUND A TREE TRIMMER **POSITION**

WHEREAS, the Commissioner of Parks & Recreation and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Parks & Recreation budget to defund a "MEO" position (\$22.60/hr), and add a "Tree Trimmer" position (\$24.65/hr) at an annual salary of \$51,272; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

That the Comptroller and City Treasurer of the City of Binghamton are Section 1. hereby authorized and directed to amend the 2023 Parks & Recreation budget to (i) defund a "MEO" position (\$22.60/hr), (ii) add a "Tree Trimmer" position (\$24.65/hr) at an annual salary of \$51,272; and (iii) fund the "Tree Trimmer" position from March 18, 2023 to December 31, 2023 as follows:
