**AN ORDINANCE TO AMEND THE 2023 PARKS
& RECREATION BUDGET TO DEFUND 2
LABORER POSITIONS AND FUND AN URBAN
FORESTER AND CREW LEADER POSITION**

WHEREAS, the Commissioner of Parks & Recreation and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Parks & Recreation budget to (i) defund 2 "Laborer" positions (\$14.26/hr); (ii) add an "Urban Forester" position (\$27.16/hr) at an annual salary of \$56,492.80; and (iii) add a "Crew Leader" position (\$25.17/hr) at an annual salary of \$52,353.60; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 15, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Parks & Recreation budget to (i) defund 2 "Laborer" positions (\$14.26/hr); (ii) add an "Urban Forester" position (\$27.16/hr) at an annual salary of \$56,492.80; and (iii) add a "Crew Leader" position (\$25.17/hr) at an annual salary of \$52,353.60; and (iv) fund the "Urban Forester" and "Crew Leader" positions from April 3, 2023 to December 31, 2023 as follows:
