## **ORDINANCE**

entitled

AN ORDINANCE AUTHORIZING THE SALE OF 183 WATER STREET TO THE WATER STREET LOCAL DEVELOPMENT CORPORATION

WHEREAS, the City of Binghamton is the owner of certain real property located at 183 Water Street, Binghamton, New York, Tax Parcel No. 160.40-2-3 (the "Premises"); and

WHEREAS, the City received an Offer to Purchase the Premises from the Water Street Local Development Corporation (the "Applicants") for \$1 for the purpose of building a public parking garage and future housing; and

WHEREAS, the Board of Estimate and Apportionment approved and recommended sale of the Premises on March 29, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain by at least a three-fourths vote as follows:

Section 1. That the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into a contract of sale and to execute all necessary and appropriate documentation, approved as to form and content by the Office of Corporation Counsel, to transfer the Premises to the Water Street Local Development Corporation, by Quitclaim Deed for \$1 to be paid by cash, certified check, or local bank check.

Section 2. That this Ordinance shall take effect immediately.
