**AN ORDINANCE TO AMEND THE 2022 FIRE
BUDGET FOR VARIOUS SERVICES**

WHEREAS, the Fire Chief and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Fire budget for various services in the amount of \$4,899.97; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 29, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Fire budget for various services in the amount of \$4,899.97 as follows:

Transfer From (Decrease):

935.04 A3410.51660 (AL Leave)
866.00 A3410.54190 (Uniforms)
\$4,899.97

Transfer To (Increase):

\$3,098.93 A3410.51630 (Out of Title)
935.04 A3410.51670 (Ambulance Pay)
866.00 A3410.54101 (Office Supplies)
\$4,899.97

Section 2. That this Ordinance shall take effect immediately.
