**A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT THE 2023 BROOME COUNTY
YOUTH BUREAU GRANT FUNDS FOR YOUTH
SPORTS PROGRAMS AND EQUIPMENT**

WHEREAS, the City of Binghamton is eligible for the 2023 Broome County Youth Bureau Grant funds in the amount of \$19,206 to be used for youth programs and equipment; and

WHEREAS, the Grant does not require local match; the grant funds will be reimbursable, and the Grant will be administered by the Commission of Parks & Recreation or his designee; and the estimated date of completion will be September 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept the 2023 Broome County Youth Bureau Grant funds in the amount of \$19,206; and that funds will be available in budget line A7310.54161 (Athletic Supplies) for this purpose.
