ORDINANCE

AN ORDINANCE APPROVING A TRANSFER FROM THE CAPITAL RESERVE PARKING GARAGE FOR THE WATER STREET DEVELOPMENT PROJECT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to transfer \$6,300,000 from the Capital Reserve – Parking Garage (A.878B) for the Water Street Development Project; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on April 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$6,300,000 from the Capital Reserve Parking Garage for the Water Street Development Project as follows:
 - (i) \$6,300,000 increase expense budget line A9950.59000 (Transfer to Capital)
 - (ii) \$6,300,000 increase revenue budget line A.49999 (Fund Balance)
 - (iii) \$6,300,000 increase revenue budget line H.45031 (Interfund Transfer)
 - (iv) \$6,300,000 increase expense budget line H5650.525272 (Water St. Parking Garage)

Section 2. That this Ordinance shall take effect immediately.
