AN ORDINANCE TO AMEND THE 2023 BUDGET FOR PARTIAL DEMOLITION OF THE PORCH AT 21 DICKINSON STREET

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 budget for partial demolition of the porch at 21 Dickinson Street, Binghamton, New York, Tax Parcel No. 160.24-1-34, in the amount of \$7,500; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on April 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

 - (i) \$7,500 increase revenue budget line H.42680 (Insurance Recoveries)
 - (ii) \$7,500 increase expense budget line H1364.54470 (Demolition)
