WHEREAS, the City Engineer and the Mayor of the City of Binghamton wishes to enter into an agreement with Atlantic Testing Laboratories for vibration monitoring and condition services agreement for the Water Street Parking Garage, in an amount not to exceed \$32,560.

RESOLVE that the Council of the City of Binghamton hereby approves the above-subject Project; and be it further

RESOLVED that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Atlantic Testing Laboratories for vibration monitoring and condition services agreement for the Water Street Parking Garage, in an amount not to exceed \$32,560; and that funds shall be deducted from budget line H5650.525080.22118 (Parking Ramps) for this purpose.
