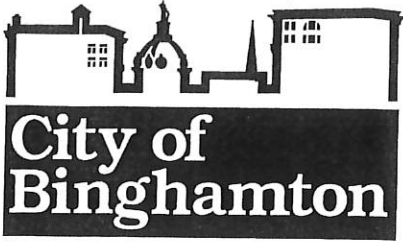
Items discussed were:

Re: Journeymen Electrician Class B Licenses

Mr. Bobnick,

The City of Binghamton Board of Electrical Examiners reviewed the applications for Paul Mantey, Joshua Page, Christian Seyerle, Robert Bower, and Jeffery Schneider. The Board did not approve the applications for Journeymen Electrician Class B Licenses. The Board unanimously agreed that if the candidates met the requirements outlined in the attached document, for Journeyman Class A Licenses, the Board would waive the hands on (practical) portion of the test and grant the applicants City of Binghamton Class A Journeyman Licenses. At that point the applicants would be duly licensed to work as Journeymen in the City of Binghamton and all municipalities that reciprocate with the City of Binghamton (Johnson City, Endicott).
