AN ORDINANCE TO AMEND THE 2023 BINGHAMTON-JOHNSON CITY JOINT SEWAGE TREATMENT FACILITIES BUDGET FOR STATE AND FEDERAL EMERGENCY DISASTER ASSISTANCE

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested an amendment to the 2023 BJCJSTF budget to (i) increase the State Aid – Emergency Disaster Fund and the Federal Aid – Emergency Disaster Fund, and (ii) increase appropriations for Reimburse Owner Recovery Expense and Professional Services to reflect the FEMA NYS-DHSES check.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Council approves and directs the Comptroller/JSB Fiscal Officer to amend and make journal budget entries in the 2023 BJCJSTF budget to (i) increase the State Aid – Emergency Disaster Fund and the Federal Aid – Emergency Disaster Fund, and (ii) increase appropriations for Reimburse Owner Recovery Expense and Professional Services to reflect the FEMA NYS-DHSES check as follows:

- (i) \$2,100,583.45 increase revenue budget line ES.43960 (State Aid Emergency Disaster Asst.)
- (ii) \$6,301,750.35 increase revenue budget line ES.44960 (Fed. Aid Emergency Disaster Asst.)
- (iii) \$1,138,905.15 increase expense budget line ES8130.55000 (Contingency)
- (iv) \$6,773,378.65 increase expense budget line ES8130.54899 (Reimburse Owner Recovery Expense)
- (v) \$ 490,050.00 increase expense budget line ES8130.54410 (Professional Services)

WHEREAS, Assembly Bill A.5762 and Senate Bill S.5605 have been introduced into the New York State Assembly and Senate respectively, for the authority to allow for the enrollment of a firefighter who failed to make a timely application to participate in such optional twenty-five year retirement plan; and

WHEREAS, Scott Pavlick may elect to be covered by the provisions of section 384 of the retirement and social security law, and shall be entitled to the full rights and benefits associated with coverage under such section.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the City of Binghamton hereby urges and approves the adoption and passage of said Assembly Bill A.5762 and Senate Bill S.5605 entitled, "An Act to authorize the City of Binghamton to offer an optional twenty-five year retirement plan to firefighter Scott Pavlick" and hereby declares that a necessity exists for the passage of such bill and that the local Legislative Body of the City of Binghamton does not have the power to enact such Legislation by Local Law; and be it further

AN ACT to authorize the city of Binghamton to offer an optional twentyfive year retirement plan to firefighter Scott Pavlick

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Notwithstanding any other provision of law to the contrary, the city of Binghamton, in the county of Broome, a participating employer in the New York state and local police and fire retirement system, which previously elected to offer the optional twenty-five year retirement plan, established pursuant to section 384 of the retirement and social security law, to firefighters employed by such city, is hereby authorized to make participation in such plan available to Scott Pavlick, a firefighter employed by the city of Binghamton, who, for reasons not ascribable to his own negligence, failed to make a timely application to participate in such optional twenty-five year retirement 10 plan. The city of Binghamton may so elect by filing with the state comp-11 troller, within nine months of the effective date of this act, a resolution of its own common council together with certification that such firefighter did not bar himself from participation in such retirement plan as a result of his own negligence. Thereafter, such firefighter may 15 elect to be covered by the provisions of section 384 of the retirement and social security law, and shall be entitled to the full rights and 17 18 benefits associated with coverage under such section, by filing a 19 request to that effect with the state comptroller within one year of the 20 effective date of this act.

§ 2. All employer past service costs associated with implementing the provisions of this act shall be borne by the city of Binghamton and may be amortized over a ten year period.

This bill would allow the City of Binghamton to elect to reopen the provisions of section 384 of the Retirement and Social Security Law for firefighter Scott Pavlick.

If this bill is enacted during the 2023 legislative session and Scott Pavlick becomes covered under the provisions of section 384, we anticipate that there will be an increase of approximately \$5,300 in the annual contributions of the City of Binghamton for the fiscal year ending March 31, 2024. In future years, this cost will vary as the billing rates and salary of Scott Pavlick change.

In addition to the annual contributions discussed above, there will be an immediate past service cost of approximately \$42,500 which will be borne by the City of Binghamton as a one-time payment. This estimate assumes that payment will be made on February 1, 2024. If the City of Binghamton elects to amortize this cost over a 10-year period, the cost for the first year including interest would be \$5,420.



The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Notwithstanding any other provision of law to the contrary, the city of Binghamton, in the county of Broome, a participating employer in the New York state and local police and fire retirement system, which previously elected to offer the optional twenty-five year retirement plan, established pursuant to section 384 of the retirement and social security law, to firefighters employed by such city, is hereby 7 authorized to make participation in such plan available to Scott 8 Pavlick, a firefighter employed by the city of Binghamton, who, for 9 reasons not ascribable to his own negligence, failed to make a timely 10 application to participate in such optional twenty-five year retirement 11 plan. The city of Binghamton may so elect by filing with the state comptroller, within nine months of the effective date of this act, a resol-13 ution of its own common council together with certification that such 14 firefighter did not bar himself from participation in such retirement plan as a result of his own negligence. Thereafter, such firefighter may 15 16 elect to be covered by the provisions of section 384 of the retirement 17 and social security law, and shall be entitled to the full rights and benefits associated with coverage under such section, by filing a 19 request to that effect with the state comptroller within one year of the 20 effective date of this act.

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE MENTAL HEALTH ASSOCIATION OF THE SOUTHERN TIER FOR USE OF FY46 AND FY47 CDBG FUNDS

WHEREAS, the Mayor of the City of Binghamton wishes to enter into an agreement with the Mental Health Association of the Southern Tier (MHAST) for use of the FY46 and FY47 CDBG funds, in an amount not to exceed \$85,000; and

WHEREAS, the funding is needed to address gaps in the crisis response service delivery, upgrade technology and equipment used by service providers, and provide additional training.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with MHAST for use of the FY46 and FY47 CDBG funds, in an amount not to exceed \$85,000; and that funds shall be deducted from budget line CD8676.533559.CDY46 and CD8676.533559.CDY47 (MHAST Mobile Crisis Services) for this purpose.
