## **ORDINANCE**

AN ORDINANCE TO ACCOUNT FOR LOST REVENUE OF \$500,000 PER THE AMERICAN RESCUE PLAN ACT GUIDELINES

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to account for lost revenue of \$500,000 from American Rescue Plan Act (ARPA) funds per the American Rescue Plan Act Guidelines; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on April 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to account for lost revenue of \$500,000 from ARPA funds in A.691 (Deferred Revenue).

Section 2. That this Ordinance shall take effect immediately.
