## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2023 GENERAL FUND TO CREATE THE COMMERCIAL FAÇADE MATCHING GRANT PROGRAM

WHEREAS, the Director of Economic Development and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund to create the Commercial Façade Matching Grant Program in the amount of \$500,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on April 11, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund to create the Commercial Façade Matching Grant Program in the amount of \$500,000 as follows:
  - (i) \$500,000 increase revenue budget line A.49999 (Fund Balance)
  - (ii) \$500,000 increase expense budget line A6989.54135 (Facades)

Section 2. That this Ordinance shall take effect immediately.
