## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2023 FINANCE BUDGET TO DEFUND A STAFF ACCOUNTANT AND FUND A JUNIOR ACCOUNTANT POSITION

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2023 Finance budget to defund a "Staff Accountant" position at an annual salary of \$60,770, and fund a "Junior Accountant" position at an annual salary of \$42,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on April 26, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Finance budget to (i) defund a "Staff Accountant" position at an annual salary of \$60,770, (ii) add a "Junior Accountant" position at an annual salary of \$42,000; and (iii) fund the "Junior Accountant" position from April 29, 2023 to December 31, 2023 as follows:
