RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A TERM AGREEMENT WITH KEYSTONE ENVIRONMENTAL SERVICES FOR THE ENVIRONMENTAL SERVICE TERM **AGREEMENT**

WHEREAS, the Mayor of the City of Binghamton wishes to enter into a term agreement with Keystone Environmental Services (KES) for environmental services in an amount not to exceed \$50,000 annually; and

WHEREAS, the rate for each service to be provided is set forth in the attached fee schedule; and

WHEREAS, a requisition for a purchase order must be submitted for requested work; and WHEREAS, funding for such services must be drawn from applicable department budget lines and approved by the Board of Contract and Supply; and

WHEREAS, the term agreement will be in effect for one (1) year with an option to renew for one (1) additional year.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVED that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into a term agreement, approved as to form and content by the Office of Corporation Counsel, with Keystone Environmental Services for environmental services, in an amount not to exceed \$50,000 annually; a requisition for a purchase order must be submitted for requested work; that funding for this purpose will be deducted from applicable department budget lines and must be approved by Board of Contract and Supply; and that the term agreement will be in effect for one year with an option to renew for another one year.
