
A RESOLUTION AUTHORIZING THE MAYOR

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with HUNT Engineers, Architects, Land Surveyors for railroad bridges visual inspections in an amount not to exceed \$41,000; and that funds will be available in budget line H5120.550011 (Bridge Improvements) for this purpose.
