ORDINANCE

AN ORDINANCE TO AMEND THE 2023
WATER/SEWER BUDGET TO DEFUND 1
WATER METER REPAIRMAN POSITION AND
FUND 1 WATER METER READER POSITION

WHEREAS, the Superintendent of Water/Sewer and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Water/Sewer budget to defund 1 "Water Meter Repairman" position at an annual salary of \$45,719, and fund 1 "Water Meter Reader" position at an annual salary of \$42,245; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 28, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Water/Sewer budget to defund 1 "Water Meter Repairman" position at an annual salary of \$45,719, and fund 1 "Water Meter Reader" position at an annual salary of \$42,245 from July 8, 2023 to December 31, 2023 as follows:

Transfer From (Decrease):

\$45,719 FX8340.51000 (Per.Ser.Wtr.Mtr.Rep.)

Transfer To (Increase):

\$18,360 FX8340.51000 (Per.Ser.Wtr.Mtr.
Read)

27,359 FX1990.55000 (Contingency)

\$45,719

Section 2. That this Ordinance shall take effect July 8, 2023.
