A RESOLUTION AUTHORIZING THE
BINGHAMTON-JOHNSON CITY JOINT
SEWAGE TREATMENT FACILITY TO ENTER
INTO AN AGREEMENT WITH GHD
CONSULTING SERVICES, INC. FOR
ENGINEERING SERVICES

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested a Resolution authorizing the BJCJSTF to enter into an agreement with GHD Consulting Services, Inc. for engineering services in an amount not to exceed \$29,007.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services, Inc. for engineering services at the BJCJSTF in amount not to exceed \$29,007; and that funds will be available in budget line ES8130.54410 (Professional Services) for this purpose; and be it further

RESOLVED, that this Resolution shall be effective when also approved by sufficient members of the Board of Trustees of the Village.
