DESCRIPTION FROM AGENDA: The City of Binghamton intends to acquire and demolish the structures and pavement on the site for the following purposes:

• expansion of the City's existing and adjacent Cheri Lindsey Park located at the northern portion of the proposed site by approximately 2.25 acres to provide for additional and enhanced facilities, amenities, and open space.

- Improving public access to the existing and adjacent multi-use River Walk located along the eastern bank of the Chenango River and at the western portion of the proposed site, together with related improvements constituting approximately 9.5 acres
- Clearing and preparation of the remaining 12.45 acres of the site along W State Street for an as yet undetermined productive use, most likely involving a mix of commercial and residential uses.

DESCRIPTION FROM AGENDA: The applicant, Stephanie Brewer, Broome County Planning Department, has proposed a mural to be painted along the façade of 186 State Street. The proposed project will make repairs/improvements to the north and front/primary facades as well.

DISCUSSION POINTS & THOSE SPEAKING:

- Staff presented the application.
- Applicant is from Broome County Planning office.
- Part of a grant given in 2019 for mural in the Southern Tier area.
- The county has previously had 5 such murals approved.
- Applicant states the mural would add visual interest and support the city's goal of becoming an arts destination area.
- The original design was approved 2021, but a new artist was chosen known as "Starfighter A".
- The mural would be the same size as the original mural that was proposed.
- Mural would be painted on the North side of the building facing Chris's Diner.
- Façade improvements are part of the application and would be necessary for the building to accept the paint used for the mural.

DESCRIPTION FROM AGENDA: The applicant, Nicholas Parisi, would like to place a six-foot-high bronze statue of Rod Serling standing in front of a doorway engraved with the words, "You unlock this door with the key of imagination." The statue will stand on a base engraved with relevant dates and information from his career.

Certificate of Appropriateness

DISCUSSION POINTS & THOSE SPEAKING:

- Staff presented the application.
- Commissioner, "Do we know what the base is at this point?"
- Applicant, "It will be 40" wide, 28" deep and 18" tall."
- Each side will have a different inscription with different aspects of his life, but the exact language for the base has not been chosen.
- The statue will be posed in the middle of a doorframe inscribed with the words, "You open this door with the key of imagination."
- The exact material for the base has not been selected yet.
- The commission can approve of the statue with the information provided, but pictures and a more complete description must be given for the base of the statue.
- Staff asked for considerations about where the statue is to be placed after it is finished.
- Commissioner of Parks and Recreation pointed to two locations in the park, one at the top where an old flagpole was removed and in the park within a triangle portion between the bandstand and the carousel.
- Commissioner asked if it could be somewhere in the bandstand, but the it would limit the area of the bandstand and ultimately take up too much room.
